The Canadian Foundation for Dental Hygiene Research and Education (CFDHRE), the Canadian Dental Assistants' Association (CDAА) and Speech-Language and Audiology Canada (SAC) are recruiting three members, preferably one from each association, to serve on the CFDHRE-CDAА Joint Grant Peer Review Committee. Peer reviewers review and decide the merit of research grant proposals submitted to the CFDHRE for funding for this research grant. **Peer Review Committee Mandate**

The mandate of the CFDHRE-CDAА Joint Peer Review Committee is to review grant applications submitted by applicants for this specific joint grant competition and to select the successful applicant. As a time-sensitive activity, peer reviewers are expected to review grants and participate in the review process within a given time frame (see below for guidelines).

**Joint-Peer Review Committee Responsibilities & Estimated Timelines**

Anticipated responsibilities and associated timelines for peer reviewers are provided below.

<b>Responsibilities</b>	<b>Estimated Timelines</b>
<b>Complete the conflict of interest form</b>	Mid- November 2015
<b>Provide input on reviewer's assessment guide</b>	November-December 2015
<b>Review proposals in a fair, objective and timely manner*</b>	November-December 2015
<b>Participate in teleconferences for final abstract selection**</b>	Early-Mid December 2015

*\* Note that reviewers will initially conduct an independent electronic review of each submission. \*\* The date and time of the teleconference(s) will be scheduled according to the members' availability in the identified month.*

**Joint-Peer Review Committee Member Education & Experience Requirements**

- Each peer reviewer must submit a statement of interest and CV/resume to the CFDHRE Program Director at [foundation@cfdhre.ca](mailto:foundation@cfdhre.ca). CV/resumes should include information about the following:
  - *Education* – Peer reviewers must have a Master's degree in their professional discipline or a related field. Consideration will be given to those close to completion of a Master's degree.
  - *Experience* –previous experience conducting published research and reviewing research proposals and/or conference abstracts is an asset.
  - Dental Hygiene applicants must be CDHA members
