- Dental Hygiene: Health services research
- Dental Hygiene: Social, cultural, environmental and population health research

## Value of Grant

The maximum amount awarded for a single award is up to \$22,000 per annum for up to 3 years. The total amount available for this initiative is \$66,000.

## Eligibility

To be eligible for consideration:

- Award must be held in Canada
- Applicants must be Registered Dental Hygienists

## Peer Review

A CIHR peer review committee will evaluate the full applications. The committee may be drawn from one of CIHR's pre-existing committees or may be created specifically for this funding opportunity.
